Faroe Island Saithe (*Pollachius virens*) targeted in Faroe Plateau and Faroe Bank, ICES Vb1 and Vb2, FAO area 27 using demersal trawl, long liners and jiggers as harvesting method and caught exclusively by the fleet of demersal trawlers and long liners that are members of FISF and the jiggers that deliver to FISF or certificate sharers.

Products originating from this fishery are eligible to enter MSC Chains of Custody. This certification applies exclusively to FISF members, FISF certificate sharers and the demersal trawlers, long liners and jiggers that deliver to FISF certificate sharers (updated certificate sharers list is available on the FISF webpage: https://www.fisf.fo/fo/partur-av-godkenning/). Certification applies only to these vessels when they are fishing for saithe (*Pollachius virens*) within the given fishery location.

Saithe (*Pollachius virens*) landed directly to FISF certificate sharers landing facilities are eligible to enter Chain of Custody and carry MSC logo if the fish is supplied and/or sold to members of FISF and/or its certificate sharers. MSC Chain of custody will commence from the point of landing and sale. All further activities from this point will be subject to Chain of Custody certification in accordance to the MSC Certification Requirement.
